Please remember to bring your tax bill, dog information (if you are getting dog license) and check or exact amount of cash with you, the Clerk/Treasurer will not be able to make change!

Dog license information

Pursuant to Wisconsin statutes 174.052, all dogs must have rabies vaccinations and dog licenses. Rabies vaccinations must be done within 30 days after the dog reaches four months, and regularly thereafter before expiration of the current certificate. Landlords are responsible for informing their tenants of this requirement.

\$ 5.00 neutered male or spayed female

\$10.00 unneutered male or unspayed female

\$35.00 multiple license (up to 12 dogs-each dog after 12 is \$3.00 per dog)

Please send a separate check and a *SELF-ADDRESSED STAMPED ENVELOPE* for the dog license. No dog license will be issued without presenting a current rabies certificate, which shows the name of the pet, the color, breed, sex, name of clinic, date and name of vaccination, plus serial number (an invoice or statement showing a date only is not valid). Proof of neutering and spaying is also required unless noted on rabies certificate. Certificate(s) and license(s) will be returned to you in your self-addressed stamped envelope. *If you have multiple dogs, please make sure you have sufficient postage on the return envelope*.

If a previously licensed dog is no longer with you, please advise the clerk/treasurer so it can be removed from records. ALL DOGS NOT LICENSED BY APRIL 1 OF EACH YEAR WILL BE SUBJECT TO A PENALTY AND LICENSE WILL NOT BE ISSUED UNTIL ALL FEE(S) ARE PAID.

Snow plowing on town roads will be done by Dalen Kobes, John LeClair and Jacob Wavrunek, who continue to keep our roads safe and in good travel and driving condition. *We remind you again, please do not push snow across roadways nor leave snow in the roadway or on shoulder, and always keep private driveways and roadways plowed wide enough to accommodate emergency vehicles.*

Another reminder, since we are now in the heating season, everyone should make sure that your outside furnace vents are clear of any obstructions, including built up snow, and if you burn wood, check your chimney for any build up and have it cleaned to prevent a chimney fire. During the Christmas season, if you have a real tree, remember to keep it well watered.

Also, we remind you that, even in winter, a burning permit is required in the Town of Two Rivers. There is no cost for the permit, but if you fail to acquire one and the fire department is dispatched, you could receive a citation. Burning permits may be obtained from Fire Chief Mark Leichtfuss at 920-517-0765 or go online and request your permit at <u>https://apps.dnr.wi.gov/burnpermits</u>. All questions regarding burning can be directed to the fire chief at the above number.

Electronic recycling has gotten costly, so, beginning January 1, 2024, the Board has implemented a fee for any TV or monitor 50 inches or under of \$20.00 for each item, paid at the time of drop off at the town recycling center. The town cannot continue to accept these items for free and then must pay a disposal fee. If your TV/Monitor is over 50 inches you will have to take it to the Manitowoc County Recycling Center at 3000 Bassroad Road in Manitowoc, which also charges a fee for these items.
